### 1. Purpose of Agreement

The Owner hereby appoints Infragenx Properties to facilitate the marketing and sale of the property located at:

## 2. Scope of Services

- Disclose all encumbrances, liens, or legal issues, if any.
- Provide reasonable access to Infragenx Properties team members and potential buyers for property visits.
- Not engage in direct sale with leads introduced by Infragenx Properties without intimation.

### 7. Buyer Introduction Clause

If a buyer introduced by Infragenx Properties purchases the property—either directly or indirectly—within **6 months of the introduction**, the full 2% commission shall be applicable and payable.

#### 8. Termination

• The agreement can be terminated by either party with a written notice of 15 days.

• If a sale is finalized with an Infragenx properties referred buyer post-termination (within 6 months), the commission still applies.
